ALICE KEPHART - Alice was born March 6, 1938 and died December 8, 1997. She was a member of the Santa Ysabel Indian Reservation and served on the board of directors for the Reservation Fire Protective District, and manager of the California Indian Forst Fire District. She organized the Volcan 4-H clubs on the reservation and worked in the office of the Santa Ysabel Tribal Hall.

Survivors include her husband, Charlie (son of Les and Adrienne Kephart); sons, Rodney & Billy Kephart; daughter, Michele Austin; brothers, Erwin, Joseph & Marcelino Osuna & two grandchildren, all of Santa Ysabel; two sisters, Myrtle Welch of Barona and Naomi Wallace of Mesa Grande. A son, Adam, died in 1988.

LUCILLE MESA CARBONE - Lucille was born October 28, 1918 in Lakeside and died December 24, 1997. She was the 5th of 6 children of Salvador and Margarita Meza who came to Lakeside in 1902 and was an important part of Lakeside's early history. Lucille was a long time member and supporter of Lakeside Historical Society and a member of OLPH Catholic Church.

She is survived by her husband Paul of 58 years; sons, Bill Carbone of Lakeside and John Carbone of Arizona; a brother, John Meza of Santa Ysabel; 9 grandchildren and 9 great-great-grandchildren.

She was a homemaker. Her interests included animals and wildlife and spending time with her family and friends. She was a member LHS.

Survivors include her husband, Robert; a son, Walter St. Clair of Arizona; sisters, Gertie St. Clair and Ruth Martin both of Texas and Jewel Irvin of Nevada and 4 grandchildren. The family suggests donations to Vitas Hospice or the Cancer Society.

MARY LOUISE ACHORD - 72 - of Texas. Our sympathy to LHS member Robert Achord of Las Vegas, NV and other members of the Achord family on the death of his mother Dec. 27th, 1997. Services were held in Texas. Mrs. Achord lived in Lakeside from 1963 to 1990. Survivors include a daughter, Sue Stafford, of Texas; sons, John of Kansas, Robert of Nevada and Darryl of Texas.

LEOLA MAURER HERMS - Leola was born May 9, 1915 in Nebraska and died on January 1, 1998 at her

home in Lakeside after a lengthy illness.

She and her husband, Henry, moved into a new home on Marilla Drive in 1938. She became an active participant in the community, serving as Lakeside PTA President as well as PTA District President and Historian. She received a Lifetime PTA Membership in 1954. She was involved in Girl Scouts and a co-partner with Shirley Sanderson of "Shir 'n Lee's", a business they both enjoyed. She was a member of the Women's Circle for the Lakeside Community Presbyterian Church and a Life Member of LHS. She was "noted" for her knitting ability and contributed much to the success of the Society as long as she was able.

Survivors include: husband, Henry, of 60 years; one daughter, Marjorie Hatcher of Borrego Springs; one son, George, of Encinitis; five grandchildren; one great-grandchild.

Grave-site services will be held at Singing Hills Memorial Park in El Cajon Thursday, January 8, 1998 at 11a.m. In lieu of flowers, donations to the Lakeside Historical Society in her memory are suggested.

ROBERT W. WATKINS (Submitted by Carol Watkins)

Bob was born in El Cajon March 31, 1914 and died January 12, 1998, the same date that his mother had died. He came to Lakeside in 1947 and opened the Watkins Bake-Sweet Shop on Main Street continuing in that location until 1972. He gained fame with his mail-order Fruit Cake business, and was known as "Fruit-Cake Watkins".

His long community service included President of the Chamber of Commerce in 1954; helped Flossie Beadle get the LaMesa Depot into Lakeside where the intention was to preserve the history of Lakeside; was instrumental in getting the Masonic Lodge, Kiwanis and Optimist Clubs founded in Lakeside and helped start the first Boy Scout Troop here. He was a willing helper at the Lakeside Historical Society of which he was a long time member. He was always on call to come down to the office and help fold newsletters as long as he was able. About a week ago he called in a receipt for his "Pound Fruit Cake" for the new Cook Book.

Survivors include two sons, Robert and Charley; a daughter Barbara; 15 grandchildren; 25 great-grandchildren (and 2 in the oven); and 1 great-great-grandson. A brother, Charles, and a sister, Evelyn.

This gentle, giant of a man even baked bread for his doctors. He was a very proud man. He went to dance once again in the heavens with his Margie.

Private services were held at Greenwood Memorial Park Friday, January 16th. Memorial contributions may be made to the Lakeside Historical Society.
