## William S. White

July 26, 1927 – September 25, 1978

William White was aboard PSA Flight 182 when the airline went down in the North Park community of San Diego, killing 144 people. He is included on the recently installed crash site memorial, listed as being from Lakeside. However, we had no information on him at LHS. A brief investigation



revealed the following:

William was born in the Philippines. He was lawfully admitted to the United States and became a naturalized citizen. He was married and had three sons. William was an aircraft inspector for PSA. He was 51 years of age at the time of his death.

William was living at 10704 Second Street at the time of his death. Interestingly, that address is now in the City of Santee; however, Santee had yet to incorporate in 1978. The Second Street address was apparently serviced by the Lakeside Post Office at that time, being in an unincorporated part of the county, so Mr. White was carried as a Lakeside resident. Local newspapers also listed him as being from Lakeside.



Another wonderful photo from Tom Isom, credited to photographer Charles A. Klindt. Though dated 1897, it may actually have been taken ten years earlier, as the trees around the hotel are virtually nonexistent and the Lakeside Boathouse does not seem to be present yet (or the fountain in front of the main entrance). The windmill left of the hotel is whirling madly—must have been a windy day. The smaller, two-story house catty-corner to the hotel (present day Maine and Woodside avenues) was built and owned (for a time) by E.W. Morse, president of the El Cajon Valley (Land) Company that established the town of Lakeside. That house may have later been owned by the Kanady family and was eventually moved about a mile west on Woodside Avenue, where it stood for many years.
