THE LAKESIDE OAKS HOTEL (1916 - 1919)?

Was there a hotel known as the Lakeside Oaks open in town a century ago? There may have been, but the facts are less than conclusive.

The 1916 San Diego City and County Directory shows "The Oaks" in the Lakeside section, with R.E. Winterstein as the proprietor. This listing continues through to the 1919 directory. There is little other evidence of its existence.

We do know that Robert E. Winterstein was born in Germany in 1844. He journeyed to the USA and landed in New York City, where he met and married Mary Eliza Laupin in about 1878. Mary switched her names around and became Eliza M. Winterstein. The couple had two daughters and two sons. A clothing manufacturer, Robert was known as a prominent New York businessman.

By 1910, the family was in our east county, where Robert bought the Brodnax farm in Jamacha, four miles south of El Cajon. Tom Brodnax was a former sheriff who had a "well known" 217-acre farm on the Sweetwater River, with plenty of water. Robert made the purchase for \$20,000 and planned to invest another \$10,000, with the intention of growing alfalfa and engaging in "dairying."

In 1912, Robert purchased The Oaks hotel in Alpine. It was described as a beautiful property of 65 acres with a large house, seven cottages, and a mixed fruit orchard, including 700 olive trees. Referred to a "well-known" resort, The Alpine Oaks was located on the northwest corner of Tavern and South Grade roads. Local directories carried The Alpine Oaks and Winterstein until 1915. Then, suddenly, there were two different "Oaks" hotels.

The Lakeside Oaks shows up in 1916, also run by Winterstein. Strangely, there is no 1916 listing for the Alpine Oaks. But the next year (1917) The Oaks appears in both Lakeside and Alpine. The husband-and-wife team was listed as real estate agents as well. To make matters more confusing, The Oaks shows up in the "Hotels" section of the directory, but is only identified as being in Lakeside. This continues into the 1919 directory.

In September 1919, the *San Diego Union* announced the sale of "the ranch known as The Oaks" to Edwin J. Lyons of New York. Presumably, this was the Alpine location, but since the Lakeside Oaks disappeared from mention after 1919, were perhaps both hotels sold? The Wintersteins moved to Fifth street in the City of San Diego. Robert died in 1921 at age 77. Eliza eventually moved to La Mesa, where she died in 1945 at the age of 92.

While the Lakeside Oaks as a hotel is a mystery, the Alpine Oaks has a clear and certain history, including photographs and a lineage that goes into the 1950s. Though it is no longer standing, the Alpine Oaks is mentioned in the book "Alpine: History of a Mountain Settlement" by Beatrice LaForce, published in 1971, and in numerous local period newspapers. Conversely, the Lakeside Oaks appears only in local directories from 1916 to 1919, with no other corroborating mention. This begs so many questions: was there really an Oaks hotel in Lakeside? Where was it located? And why is there so little evidence of its existence? History's mysteries can be most annoying ...

A miscellany of LHS-related notes: LHS Lifetime member Ann Gilbert was honored by Lakeside's River Park Conservancy as their 2024 Joan Burnett Achievement Award. Congratulations and well deserved, Ann! ... Back in 2017, Ramona resident Madison Kirkman spoke to us about his passion: saving one of the last intact McKeen Motor Cars in the world—the "Cuyamaca." This unique railroad car actually traveled the rails of Lakeside back in the day. Madi-



son was able to transport the car from Alaska to his backyard in Ramona, where he continues to work on it today. Fast forward to more recently, when Madison found and acquired a rare McKeen Trailer Car (above photo, at right). one of only three known to still exist. The two pieces of RR history are together again, perhaps for the first time in over 70 years! For more information about Madison's project, you can follow him on Facebook ... For those of you who remember the Congress of History of San Diego and Imperial Counties, the venerable organization that served to connect many local societies with history conferences and the like, voted to dissolve earlier this year. THE LAST CAROB TREE IS GONE

In 1936, 22-year-old Edna Swink (Kouns) and her high school friends planted a little forest of Carob trees on the parkway strip in front of the Olde Community Church, along Maine Avenue and Parkside Street. That's Edna (above right) in front of one of her trees in 2015, at age 100 (Edna, not the tree). Over the years, one by one, the venerable trees have fallen to age and disease (and possibly the impact of underground utilities), until there was only one left. It was appropriate the last tree stood in front of the old Manse (or pastor's house) that now serves LHS as our Lakeside History Museum. But on April 7, the 89-year-old tree fell to the ages (above left). Except for some minor damage to our fence, there is little trace of our last tree. Gone, but not forgotten.
